Tax Filing Status	Max Annual Tax Credit	Annual Maximum Contribution	
		75% tax credit (2-year commitment)	50% tax credit (1-year commitment)
Single individual or head of household	up to \$1,000	\$1,333	\$2,000
Married couple filing a joint return	up to \$2,000	\$2,667	\$4,000
Legal business entity	up to \$100,000	\$133,333	\$200,000

How to Earn Your Tax Credit

1. Commit Now

Make your contribution commitment online for 2020 tax credits at www.GOforCatholicSchools.com (takes just a few minutes!).

- *Decide How You want to Pay Your Commitment
 - i. Timing of Payment: One Lump Sum **or** Monthly payments over the remainder of the Calendar Year
 - ii. Form of Payment: Check, e-Check/ACH or Credit Card
- 2. Pay on Your Commitment
- 3. Take the Credit for Your Contribution.
 - In February, the OTC publishes notice of tax credits and GO sends you a summary of your contributions along with simple instructions for how to claim your tax credit on your 2018 Oklahoma income tax return.
 - Note: You will claim the tax credit when you file your 2019 taxes in 2020.
