ARTICLE X


Interpretation


10.2 The By-Laws or amended By-Laws shall take effect on the date is approved by the Council, as evidenced by its Chair's signature, together with all other required signatures.


Amendment 1

Article VI Committees Section 6.1 Standing Committees is hereby amended by combining the Development Committee (Section 6.1.5) and the Public Relations Committee (Section 6.1.6) into a single committee with the following language:


6.1.5 DEVELOPMENT COMMITTEE: The Development Committee oversees long-range capital development campaigns and annual fundraising events. The Development Committee communicates with the parents, parishes, and public about Catholic education and All Saints Catholic School which will assist in the promotion of the School and recruitment/retention of students for the School. The committee recommends policies and strategies with the Principals and School Advisory Council for long-range planning for the school including coordinating a schedule of fundraising events through the master calendar. The Committee is expected to provide a budget to the Finance Committee by December 1 of each year for use in developing the School's budget.

Section 6.1.7 SPIRITUAL LIFE DEVELOPMENT COMMITTEE is now numbered 6.1.6.


